SHARE YOUR VIEWS ON LEVEL TWO – TERMS AND CONDITIONS

Promotion

1. The Share Your Views on Level Two Promotion ("**Promotion**") runs from Friday 1 May 2026 until 11am Monday 30 November 2026, with the last Monday of each month being a draw day.

Entry

2. To enter the Promotion and be eligible to win a prize ("**Entry**"), entrants must:
 - a. Leave a positive review on the Level Two Bar & Lounge Google or Tripadvisor profile and send a screenshot or evidence of their review to SkyCity Queenstown via social media or email;
 - b. be aged 20 years or over; and
 - c. be a SHOW by SkyCity Rewards member, during the period of the Promotion.
3. Employees of SkyCity and their families are not eligible to enter.

Prize

A prize draw will be held at 11am on the last Monday of each month during the Promotion, at which time one Entry will be randomly drawn from all eligible Entries received in that month and the winner will win \$50 worth of Rewards Points.
