

SKYCITY QUEENSTOWN

BLOOMING REWARDS – TERMS AND CONDITIONS

1. The Blooming Rewards promotion (“**Promotion**”) runs from 11am on Tuesday 1 September 2026 until 9pm on Tuesday 29 September 2026 (inclusive of draw times) (“**Promotion Period**”) with each Tuesday during the Promotion Period being a draw day (each a “**Draw Day**”).
2. The Promotion is exclusive to SHOW by SkyCity Rewards and Premier Rewards members (“**Members**”). However, Members who are in any way excluded from entering SkyCity (including those excluded after their entries have been accepted), commission players and employees of SkyCity, its related companies or its advertising agencies are not eligible to participate in the Promotion.

Prize Draws

3. A prize draw will be conducted by a licensed SkyCity representative on the Main Gaming Floor at SkyCity Queenstown at 9pm on each Draw Day (each a “**Prize Draw**”) during the period of the Promotion. At each Prize Draw, one winner will be drawn from all eligible Entries (as defined in clause 8) received at the time of the relevant Prize Draw and, subject to clause 9, that winner will win the cash prize described in clause 4 (as applicable).
4. The base prizes available to be won on each draw day will be:
 - a) \$200 cash and \$100 worth of Rewards Points on 8 September;
 - b) \$300 cash and \$100 worth of Rewards Points on 15 September;
 - c) \$400 cash and \$100 worth of Rewards Points on 22 September;
 - d) \$600 cash and \$200 worth of Rewards Points on 29 September.

If a prize is not claimed in accordance with clause 9 at any Prize Draw, then that prize will be rolled over to the next Prize Draw (and will be combined with the base prize available to be won at that next Prize Draw), and so on and so forth, including carrying over to the following Draw Day if not won, until the cash prize is successfully won/claimed at a Prize Draw. Where the cash prize is successfully won/claimed at a Prize Draw, then the cash prize available to be won at the next Prize Draw will revert to the base prize stated.

5. To ensure a winner is found for the final Prize Draw at 9pm on 29 September 2026, that Prize Draw will be a **Must-Win Prize Draw**.
6. The maximum prize amount is \$1,500 in cash and \$500 worth of rewards points.

Entry

7. A Member may not win more than once on a Draw Day but may win more than once during the Promotion.

8. We are The entry period ("**Entry Period**") for each Prize Draw is from 11am on Tuesday 1 September until 15 minutes prior to the relevant Prize Draw on a Draw Day.
9. A Member may earn a maximum of one entry ("**Entry**") per gaming day during the Entry Period by earning 1 Reward Point or Premier Point (as applicable) from table game and/or gaming machine play at SkyCity Queenstown. The earning of additional Rewards Points or Premier Points (as applicable) in a gaming day during the Entry Period will not give the Member additional Entries into the Prize Draw. For the avoidance of doubt, a Member may earn a maximum of 29 entries during the Promotion. All winning Entries will be discarded from the promotional draw barrel once they have been drawn. All non-winning Entries will remain in the promotional draw barrel and will remain eligible for subsequent Prize Draws.
10. In order for an Entry to be valid, a Member must:
 - a) print their entry ticket from the SHOW by SkyCity Rewards kiosk at SkyCity Queenstown after 15 minutes of earning and within 24 hours
 - b) place their printed Entry Ticket into the prize barrel at the entrance of SkyCity Queenstown prior to 9pm on the relevant Draw Day.
11. To be eligible to win the Prize Draw on the Draw Day, a Member must:
 - a) be physically present at the time of the Prize Draw; and
 - b) present their valid SHOW by SkyCity Rewards or Premier Rewards (as applicable) card and a satisfactory form of government issued photo ID, to the SkyCity representative hosting the Promotion on the Main Gaming Floor at SkyCity Queenstown within one minute of the winner being announced.

If a winner does not physically present themselves, but the SkyCity representative receives visual or audio notification from a SkyCity representative that the winner is on SkyCity's premises, then the timeframe may be extended at the discretion of the SkyCity host to enable that winner to present themselves. If a winner still cannot present themselves together with their SHOW by SkyCity Rewards or Premier Rewards (as applicable) card and valid photo ID within that timeframe, then;

 - c) in respect of the Must-Win Prize Draw, another Entry will be drawn from all eligible Entries and the process set out above will be repeated until an eventual winner is found;
 - d) in respect of all Prize Draws other than the Must-Win Prize Draw, the relevant prize will not be awarded, and the prize amount will jackpot to the next Prize Draw in accordance with clause 4.

General

12. For the purposes of clause 4, Premier Points or Rewards Points are standard loyalty points (or equivalent measure as determined by SkyCity at its direction) earned by Premier Rewards members or SHOW by SkyCity Rewards members (as applicable) from gaming at SkyCity Queenstown Casino pursuant to the terms of the SkyCity Premier Rewards and SHOW by SkyCity Rewards programme (as applicable) and recorded by SkyCity's electronic monitoring system and specifically exclude Premier Points or Rewards Points gifted to or won by Premier Rewards members or SHOW by SkyCity Rewards members (as applicable) and bonus loyalty points issued to Premier Rewards members or SHOW by SkyCity Rewards members (as applicable) in connection with any other promotion.

General

13. SkyCity's decision is final, and no discussion or correspondence will be entered into.
14. To the extent permitted by law and subject to obtaining any applicable regulatory approvals, SkyCity reserved the right to change any Prize Draw time, Draw Day date, delay the start of the Promotion, extent or cancel the Promotion or alter any of these Terms and Conditions without notice.
15. In the event that SkyCity Queenstown is closed to the public, SkyCity reserves the right to cancel any Draw Day or hold a substitute Draw Day (or Draw Days, as applicable).
16. To the extent permitted by law, neither SkyCity nor any other person or party associated with the Promotion will be liable to any person for:
- a) any loss, damage or personal injury suffered in connection with participation in the Promotion; or
 - b) any unforeseen card or system failure or unplanned system delay, including but not limited to where a Members Premier Rewards or SHOW by SkyCity Rewards card is not swiped or inserted or is incorrectly swiped or inserted. In such circumstances, SkyCity is under no obligation to award any Premier Point(s)/Rewards Point(s), a valid Entry and/or prizes (whichever is applicable) to the Member or cancel any Entry awarded to any Member.
17. Participation in the Promotion and/or acceptance of a prize confirms acceptance to participate in any reasonable publicity or advertising of SkyCity.
18. Participation in the Promotion implies full acceptance of these Terms and Conditions. Failure to observe any of these Terms and Conditions may result in disqualification from the Promotion.
